This is for information of all concerned that the candidates who failed in the HSLC Examination, 2024 and desire to continue their study will be required to take re-admission in class X for regular classes. Then only they will be allowed to appear in subsequent examination. The followings are to be noted in connection with re-admission.

1. Candidates may take admission in the same schools from where they appeared HSLC Examination 2023. If the parent school is not in a position to offer re-admission students may take admission in any other school. However Registration transfer for the same has to be applied online before 30th August, 2024.
2. No change in the registration number. Candidates will have to appear in subsequent examination with the same registration number, provided that he/she appears from same school.
3. Candidates are allowed to change Elective subject if desired so. The last date for application for the same is 25th September, 2024
4. Schools where the candidates will take re-admission will make arrangement for assessment of practical of the candidates for the period of study and they will have to send practical marks/internal assessments marks to SEBA accordingly.
5. The candidates (repeaters) will have to appear compulsorily in the half yearly examination of class X, failing which they will not be allowed to appear in next Exam.
6. Head of the Institution will supervise their attendance in class and monitor their progress in their studies and also include them in the Remedial classes according to their need.
7. Head of the Schools will ensure that the re-admission process is completed by 30th August, 2024
